Sheriff's Deed. On 19 Nov 1762 John Fairlamb, sheriff of Chester County, to William Pearson of East Caln, saddle tree maker. Joseph Bishop in the Court of Common Pleas recovered against Henry Thomson of East Bradford, mason, a debt of £100 & 72 shillings damages to be levied on the lands of said Henry Thomson. John Fairlamb, for £94.10 subject to a mortgage of £32 owed the General

 Loan Office, granted to William Pearson a tract of land in East Bradford bounded by land of John Baldwin, Isaac Thompson, Thomas Price & George Powell containing 111 acres. Signed John Fairlamb,

sheriff. Delivered in the presence of William Swaffer & E. Price. Recorded 18 Apr 1763. (N13:8).

Mortgage. On 22 Nov 1763 Bees Gatlive of Uwchlan, yeoman, & Ann his wife to David Owen of Uwchlan, yeoman. Rees Gatlive & Ann his wife for £100 granted to David Owen a tract of land in Uwchlan containing 100 acres being part of the estate formerly of Charles Gatlive, dec. containing 200 acres conveyed to Charles Gatlive in his lifetime by Edward Kinison & Mary his wife by deed dated 5 Jan 1722, whereas Charles Gatlive by his will dated 12 Dec 1742 & bequeathed to his eldest son Rees Gatlive 1/2 part of the 200 acres & made Rees Gatlive his sole executor, & soon after died. Signed Enoch James. Delivered in the presence of William Braneman & Catherine Jones. Recorded 19 Apr 1763. (N13:11).

Mortgage. On 6 Apr 1763 Edward Mangner of West Caln, yeoman, & Eamy his wife to Joseph Bishop of West Caln, yeoman. Edward Mangner stands bound to Joseph Bishop for £150 conditioned on payment of £75 plus interest on 6 Apr 1765. Edward Mangner & Eamy his wife to better secure said debt granted to Joseph Bishop a tract of land in West Caln bounded by land of Joseph Cox containing 174 acres. Signed Edward Mangner & Eamy Mangner. Delivered in the presence of John Miller & Thomas Babb. Recorded 19 Apr 1763. (N13:13).

George McCleave stands bound to Philotsia & Amos Strettell for £120 conditioned on payment of £60 plus interest on 18 Dec 1763. George McCleave to better secure said debt granted to Isaac Voto & Sarah Voto. Recorded 14 Dec 1762. (M12:495).

Deed. On 16 Feb 1762 John Phipps of Uwchlan, yeoman, & Sarah his wife to Dennis Whelon of Uwchlan, yeoman. Whereas Benjamin Davis, sheriff, by deed dated 17 Mar 1761 granted to John Phipps a tract of land in Uwchlan bounded by the Welch line, land formerly of Robert Williams, land formerly of Peter Aston, land formerly of David Lloyd & land of Griffith John containing 110 acres. Now John Phipps & Sarah his wife for £277.18.9 granted to Dennis Whelon all the said 110 acres. Signed John Phipps & Sarah Phipps. Delivered in the presence of Noble Butler, William Butler & Benjamin Butler. Recorded 15 Dec 1762. (M12:497).

Mortgage. On 10 Dec 1762 John Huggins of New Providence in the County of Philadelphia, yeoman, & Elizabeth his wife to Henry Harrison of the City of Philadelphia, Esq. John Huggins stands bound to Henry Harrison for £440 conditioned on payment of £220 plus interest on 10 Dec 1763. John Huggins & Elizabeth his wife to better secure said debt granted to Henry Harrison a tract of land in West Bradford, bounded by land of allotted to John Taylor, land allotted to Philip Taylor's children, land of John Taylor, Thomas Legate & William Richards containing 89 acres being the land David Richards of the City of Philadelphia, formerly weaver, but now sawyer, & Sarah his wife by deed dated 4 Dec instant granted to John Huggins. John Worrall stands bound to Jonathan Worrall for £96.6.8 conditioned on payment of £48.3.4 to be paid within 6 days after the decease of Hannah Worrall, widow of John Worrall, of Middletown, yeoman, dec. John Worrall stands bound to George Worrall for £48.3.4 conditioned on payment of £24.1.8 to be paid within 6 days after the decease of Hannah Worrall. John Salkeld to better secure said debt granted to David Scholefield a tract of land in West Caln bounded by land of Peter Babb, John Salkeld, Sr., land late of John Salkeld, dec. & land of Samuel Love containing 100 acres. Signed John Salkeld. Delivered in the presence of Henry H. Graham & E. Price. Recorded 27 Dec 1762. (M12:503).

Deed. On 13 Nov 1762 Nathaniel Squibb of Chester, cordwainer, & Margery his wife to Gervase Burgess of Chester, merchant. Nathaniel Squibb & Margery his wife for £160 granted to Gervase Burgess a brick house & tract of land in Chester bounded by land of Thomas Coebourn, land late of William Coebourn but now of Richard Barnett containing 22 acres, being the land William Pearson of Chester, saddletree maker by deed dated 1 May 1761 granted to Nathaniel Squibb. Signed Nathaniel Squibb & Margery Squibb. Delivered in the presence of Samuel Shaw & David Skinner. Recorded 28 Dec 1762. (M12:505).

Release. On 2 Dec 1733 George Chandler of Chichester, yeoman to William Hughes of Chester, yeoman. Whereas William Penn by patent dated 1 Apr 1685 granted to Thomas Garret a tract of land containing 100 acres. Whereas Thomas Garret on the back of said patent dated 9 Dec 1685 granted the 100 acres to James Brown & James Brown by patent dated 9 Mar 1687 granted the 100 acres to John Chandler & Jane his wife. John Chandler died & the said 100 acres fell to Jane his widow, who in 1695 granted the same 100 acres to George Chandler (the late father of the George party to this). Whereas John Taylor, late sheriff of Chester County, by virtue of a judgement dated 26 Nov 1724 seized the 100 acres & by deed dated 18 July 1724 sold the same 100 acres to George Chandler. Whereas Swithin Chandler, William Key, containing 152 acres being part of the 500 + acres. Signed Mordecai Cloud, Jeremiah Cloud & Anne Cloud. Delivered in the presence of Joseph Townsend, Robert Mills & Richard Jones. Peaceable possession given to Joseph Davis in the presence of Robert Wice & Thomas Toogood. Recorded 27 Apr 1747. (G7:152).

Mortgage. On 3 Jan 1746/7 Rees Williams, Jr. of Chester, yeoman, to Joseph Parker of Chester, gentleman. Rees Williams, Jr. for £50 granted to Joseph Parker one third part of the saw mill, grist mill & bolting mill & the mill land in Chester bounded by the mill race & Chester Creek, containing 4 acres. Rees Williams to pay Joseph Parker £50 plus interest on or before 3 Jan 1748/9. Signed Rees Williams. Delivered in the presence of Eleanor Phillips, John Baldwin & Henry Graham. Recorded 29 Apr 1747. (G7:155).

Mortgage. On 14 May 1747 John Strode of Bradford, yeoman, to Abraham Darlington of Birmingham, yeoman. John Strode for £59 granted to Abraham Darlington a tract in Westtown bounded by land of Richard Woodward & land in the tenure of George Strode containing 200 acres. John Strode to pay Abraham Darlington £59 plus interest in yearly payments, to be paid in full on or before 14 May 1750. Signed John Strode. Delivered in the presence of Thomas Cummings, Joseph Parker & Henry Graham. Recorded 22 May 1747. (G7:158).

Mortgage. On 25 May 1747 Robert Morriall of Newtown, blacksmith, to William Branson of the City of Philadelphia, merchant. Whereas Robert Morriall stands bound to William Branson for £148.14 conditioned on the payment of £74.7 on 16 Nov 1748. Whereas Robert Morriall is further bound to William Branson for £133.13.2 on condition of payment of £66.16.6 to be paid on 16 Nov 1749. Robert Morriall to better secure said payments granted to William Branson a tract in Newtown bounded by land of Thomas Pierce, the Great Road leading to Conestogoe, land of David Rees, the Great Road leading to Radnor Church, land of John Jones & land of Humpbrey Wayne, containing 95 acres, being part of 134 acres. Thomas Cooper of Newtown, yeoman & Catherine his wife, by deed dated 23 Mar 1733/4 granted to Robert Morriall. Signed Robert Morriall. Delivered in the presence of John Reily & Robert Forde. Recorded 2 June 1747. (G7:160).

Deed. On 9 June 1742 Edmond Williams of Darby, yeomen, & Elizabeth his wife, to Job Harvey of Darby, yeoman. Whereas the

commissioners of William Penn granted to John Blunston 500 acres, being part of 1500 acres. John Blunston made his will dated 17 July 1723 & bequeathed the said 500 acres to his son Samuel Blunston. Samuel Blunston & Sarah his wife by deed dated 30 Apr & 1 May 1728 granted to Benjamin Pearson a lot being part of the 500 acres. Benjamin Pearson & Elizabeth his wife by deed dated 29 & 30 Mar 1734 granted the said lot to John Owen of Chester. Whereas John Owen & Hannah his wife by deed dated 18 & 19 Sep 1734 granted the add lot to Thomas Freese of Ridley. Whereas Thomas Freese & Anne his wife by deed dated 5 & 6 Dec 1737 granted the said lot to Edmond Williams. Now Edmond Williams & Elizabeth his wife for £30 granted to Job Harvey a lot in Darby bounded by High Street, a lot James Hunt, the mill race & a lot of Job Harvey. Signed Edmond Williams & Elizabeth Williams. Delivered in the presence John Paschall & Joshua Pearson. Recorded 4 June 1747. (G7:164).

John, Samuel & Anne Bethell for £120 granted to Job Harvey, one full undivided fourth part of the fulling mill & 2 pieces of land where the fulling mill stands in Darby, one parcel being bounded by the King's Road, Darby Mill Race & Darby Mill Road & the other parcel where the fulling mill stands bounded by the Mill race & Darby Creek, both parcels containing in whole 1 1/4 + acres, with the yearly rent of 20 shillings to be paid the heirs of John Blunston, Sr., dec. Signed John Bethell, Samuel Bethell & Anne Bethell. Delivered in the presence of Benjamin Cliffe & Richard Parker. Recorded 5 June 1747. (G7:167).

Deed. On 27 July 1710 Neels Boon of Darby, one of the sons of Andreas Swanson Boon, late of the County of Philadelphia, yeoman, dec., to Job Harvey of Darby, cloth maker. Whereas the late commissioners of William Penn by deed dated 25 Aug 1688 granted to Andrea Swanson Boon a tract of land in Darby bounded by land of Swan Boon & Richard Parker, containing 80 1/2 acres. Whereas Joseph Wood, late of Darby, dec. by deed dated 1 June 1691 granted Andreas Swanson Boon a tract in Darby bounded by Darby Creek, land late of William Gabitas, other land of Andreas Swanson Boon & Darby Bridge - containing 70 acres. Whereas William Gabitas, late of Philadelphia, mill wright, by deed dated 2 Dec 1694 granted to Andreas Swanson Boon a tract in Darby bounded by Darby Creek & other land
