ANTHONY COOK OF ULSTER COUNTY, NEW YORK, AND HIS DESCENDANTS IN MERCER COUNTY, NEW JERSEY

This documentary recovery of the descendants of Henry Cook, the progenitor of this family of Cook in Maidenhead Township, Hunterdon County, now Lawrence Township, Mercer County, New Jersey, who died there testate in 1723, resolves the mere assumptions stated in P. V. Lawson, *Family Genealogy* (Menasha, Wis. 1903), p. 191; in F. B. Lee, *Genealogical and Personal Memorial of Mercer County, N.J.* (1907), pp. 105, 519, 717; in E. M. Woodward and J. F. Hageman, *History of Burlington and Mercer Counties, N.J.* (1883), p. 848, and corrects as Cook the identification of "Anthony Cock" in H. M. Cox, *The Cox Family in America* (Somerville, N.J., 1912), pp. 35 and 107.

1. ANTHONY COOK, one of the soldiers in the British armed forces under Col. Richard Nicolls which arrived at New Amsterdam in August 1664 in a fleet of four ships of the British Navy and received the surrender of New Netherland from the Dutch, with 23 fellow soldiers garrisoned at Kingston, N.Y., accepted the Governor's offer of a grant of land in the newly laid out village of Marbletown nearby in September 1668 (*Minutes of the Executive Council of the Province of New York* 1:247).

Anthony Cook and Jane Crawford were married by a justice of the peace in Kingston on 13 Sept. 1667 (*Old Ulster Hist. and Gen. Magazine* 1:350; *Registers of the Old Dutch Church of Kingston, N.Y.* (1891), p. 502, has the marriage banns dated 28 Sept. 1667, the discrepancy in date being unexplained). The bride was possibly a daughter of the David Crawford ("Krafford" in the record) who had arrived at New Amsterdam from Holland in the Ship *The Fox* ("D'Vos") with his wife and a child of 14 years on 31 Aug. 1662. Possibly this immigrant was also the David Crawford who was one of Anthony Cook's fellow soldiers at Kingston in 1668. Anthony Cook died in 1671, and his widow Jane (Crawford) Cook married, secondly, soon after the publication of the banns at Kingston on 7 Dec. 1672, William Fisher, who had been one of his fellow soldiers in the garrison there. According to the *Register of the Dutch Church of Kingston, N.Y.*, William and Jane (Crawford) (Cook) Fisher had issue: (1) William, born ca. 1673, died 1695-1715; (2) Eliza-

beth, baptised 19 Jan. 1679; (3) Edward, baptised 2 Dec. 1683; (4) David, baptised 18 Sept. 1687, died by 1692; and (5) David, baptised 17 April 1692.

William Fisher of Ulster County, N.Y., yeoman, made a written agreement with Sarah Farr, widow, of Springfield Township, Burlington County, N.J., dated 22 April 1696, for the purchase of her 1600 acre plantation near the town of Burlington (*N.J. Archives* 21:484), and in her will of 5 Aug. 1698, said Sarah Farr of Burlington instructs her executors to sell the said 1600 acres to William Fisher as agreed (*N. J. Wills* 1:159 f.). Also by deed of 6 Dec. 1696, said Sarah Farr, widow of Elias Farr of Burlington, N.J., conveyed to said William Fisher, now also of Burlington County, yeoman, a 1705 acre plantation on Assiscunk Creek and the Burlington highway, between Samuel Oldale and Godfrey Hancock, with a house lot in Burlington Town (*N.J. Archives* 21:510, 350, 364, 377). William Fisher, Gentleman, was commissioned High Sheriff of Burlington County on 14 Aug. 1703, again on 2 Oct. 1704 (*Penn. Gen. Mag.* 6:181, 185. See also *N.J. Archives* 3:152 f., and the *Burlington Court Book* 1680-1709.). The will of William Fisher of Burlington, N.J., yeoman, dated 18 Feb. 1714/15, proved 30 June 1718 (*N.J. Wills* 1:164) names children viz. Edward, David and Ann, wife of John Hancock; devises real and personal estate; and appoints John Talbot, rector of St. Mary's Church, Burlington, and Abraham Hewlings of Evesham Township, Burlington County, executors. The son-in-law John Hancock was evidently the testator of that name, of Mansfield Township, said county, whose will was dated 4 Feb. 1732 (*N.J.* 30:220).

William Fisher's stepson Henry Cook also removed from Kingston to Burlington County between 1696 and 1702.

2. HENRY² COOK, baptised 12 April 1671 by the pastor of the Reformed Dutch Church in New York City, son of Anthony and Jane (Crawford) Cook of Kingston, Ulster County, New York, removed thence with his family in 1696-1702 to Burlington County, New Jersey, as had his stepfather William Fisher and family in 1696 as above-said, after which year their names are not found in the register of the Kingston Church.

By deed of 17 Feb. 1701/2 Francis Collings of the Town and County of Burlington, N.J., bricklayer, conveyed to Henry Cooke of same County, 100 acres of land, being one share of land belonging to four sevenths parts of one proprietary of land in the Province of West New Jersey which said Collings purchased of Edward Byllings by deed of 1 and 2 July 1677; and, by deed of 1 Nov. 1708, Henry Cooke of Burlington County, N.J., yeoman, conveyed the same to Henry Peeps of said County, husbandman, reciting the abovesaid deed of 17 Feb. 1701/2, recorded in West Jersey Deed Book B, part 2, p. 730, and AAA, p. 338, respectively. The grantee Henry Peeps, of Burlington, N.J., yeoman, died testate in 1718, bequeathing a 120 acre farm in Springfield Township (*N.J. Wills* 1:358).

Henry Cook served on the grand jury at the Quarter Sessions Court of Burlington County, N.J., on 12 Dec. 1704, 10 Dec. 1706, 2nd Tuesday in June 1709 and 13 Sept. 1709. Henry Cook was chosen Constable for Mansfield Township on 23 March 1707/8 for the year (*The Burlington Court Book 1680-1709*, published 1944). Henry Cook witnessed the will of Edward Bolton of Mansfield Township, Burlington County, N.J., dated 28 Sept. 1713 (*N.J. Wills* 1:47). Henry Cook and family finally settled in Maidenhead Township, in that part of old Burlington County which was set off as Hunterdon County in 1714. Thus, Henry Cook was chosen a surveyor of highways at the Maidenhead Town Meeting of 2 Jan. 1721. He died there testate between 15 Nov. and 20 Jan. 1723/4.

The record of the marriage of Henry Cook to his Dutch wife Wyntje Franse Klauw has not been found but their names appear as the parents of two children baptised in 1695 and 1696, in the register of the Dutch Church of Kingston, N.Y. Wife "Wineford" was so named in the will of said Henry Cook, quoted below, evidently the scribe's attempt to anglicise the Dutch name "Wyntje" (Lavinia). "Wineah Cook" was one of three witnesses to the will of Gershom Moore of Maidenhead Township, Hunterdon County, dated 3 April 1722 (*ibid.* 324). As "Wineford Cook" she qualified as co-executor of her husband's will on 1 Sept. 1724.

She was the daughter of Frans Pietersen Klauw of Beverwyck in 1656, of Kinderhook in 1680, who had a wife Elsje living in 1684; and issue: (1) Hendrick Fransen Klauw who married 14 Oct. 1685 Cornelia Andriesse Sharp; (2) Jurriaen Fransen Klauw of Kinderhook in 1720 who married Maria Janse; (3) Jannetje Franse Klauw who married 28 March 1693 Lambert Jochumsz Van Valkenburgh at Albany and had daughter Elsje baptised there 3 Sept. 1693; (4) Judik Franse Klauw married Jacob Janse van Hoesen and had daughter Marietje baptised 3 Sept. 1693 at Albany and daughter Elsje baptized there 12

Feb. 1696, son Leisler baptised at Kingston, 8 May 1698; (5) Wyntje Franse Klauw married Henry Cook of Kingston, N.Y. and of Maidenhead, Hunterdon County, N. J., and she d. after 1 Sept. 1724 (see *Collections on the History of Albany, N.Y.* 3:107; Register of the Albany Church in *Holland Society Year Book* for 1904).

The will of Henry Cook of Maidenhead, Hunterdon County, N.J., yeoman, dated 15 Nov. 1723, proved 20 Jan. 1723/4 (briefly abstracted in *N.J. Wills* 1:206), desires "decent Christian burial at the discretion of my executors"; bequeaths to "Wineford, my dearly beloved wife," all movable estate, one-third of his lands, and "the best room in my now dwelling house" during her lifetime; to sons William and Anthony Cook "my house and all my lands, to be equally divided between them, and their heirs and assigns forever"; "my three daughters that are now married viz. Alice, Mary and Jane, shall have five pounds each of them, at nine shillings and two pence per ounce, also that my three daughters that are not married, Elizabeth, Sarah and Rebecca, shall have ten pounds each of them, like money, all to be paid by my two sons on condition that they be not forced to purchase the land of Col. Coxe, and if so, I desire that they would make their sisters some consideration if they are able to do it; my will is that if the land before mentioned must be purchased before my son Anthony comes of age, that then my said son shall live with my son William in order to help him forward in said purchase, otherwise I desire he may be left with his mother to be brought up as she thinks fit"; servant boy to live and serve my said son William in case of his making said purchase until my son Anthony comes to the age of 21 years; and appoints wife and son William as executors; signed by mark ("H.C."); witnesses: John Abbade, Philip Phillips, Peter Lott. On 20 Jan. 1723/4, Winifred (her X mark) Cook and William (his X mark) Cook signed and qualified as executors of the will. Appended to the will, as recorded in Book No. 2, p. 283, is the certificate of probate: "Proved the first day of September, Anno Dom. 1724 (at Burlington) before Samuel Bustill, Deputy Surrogate of the Western Division of the Province of New Jersey, and probate and letters testamentary, sealed by His Excellency the Governor, were granted the 6th day of January, in the year abovesaid, unto Wineford Cook, wife and relict of the deceased, and unto William Cook, son of the said deceased, in the above will named" etc. In the printed abstract the name "Janet" is an error for Jane. The inventory of the personal estate of Henry Cook of Maidenhead, decd, dated 21 Jan. 1723/4, was made by Alexander Lockhart and Philip Phillips, and appraised at £172/6/6, including such items as 50 bush-

els of wheat at 7 pounds 6 shillings and a mulatto boy aged 12 years at £30.

McCracken, *The Welcome Claimants* (Baltimore 1970), 54-56, 613, which reference shows evidence that George Rozell or Rossell of Maidenhead probably married another daughter of Henry and Wyntje.
- vii. Sarah, m. by N.J. lic. dated 30 April 1729, John Stephens of Brunswick Township, Middlesex County, N.J., joyner, of whom nothing further was found (*Gen. Mag. of N.J.* 15:21, *N.J. Archives* 22:93).
- viii. Rebecca, named in will of her father in 1723

as then unmarried; no further record found.

3. WILLIAM³ COOK, elder son of Henry and Wyntje (Klauw) Cook of Kingston, N.Y., and of Maidenhead Township, Hunterdon County, N.J., died in the latter place at some date after 1756, but his estate is not found in the county probate records to establish it. He married, about 1722, Hannah Phillips, born 11 Feb. 1702, daughter of Philip Phillips, of Maidenhead Township, and his first wife Hannah Stockton (TAG, *supra*, 33:45-47). The children shown below were listed on 3 March 1756 in the Maidenhead Town Register which has been examined. Extracts have been published in the *History of Burlington and Mercer Counties* p. 848.

4. ANTHONY³ COOK, second son of Henry and Wyntje (Klauw) Cook, died testate in Trenton Township, Hunterdon County, N.J., between 6 Jan. and 3 Feb. 1781; married Keziah Roberts, daughter of Jonathan and Mary Roberts of said township.

5. HENRY⁴ COOK, born 17 Dec. 1724, eldest son of William and Hannah (Phillips) Cook, of Maidenhead Township, Hunterdon County, died there testate, between 1st October 1786 and 26th of November 1786. According to the Town Register, he held these appointments: Collector of Taxes in 1767; Overseer of Roads, 1769; Justice of the Peace, 1770; Collector and Overseer, 1774; Overseer of the Poor, 1775 and 1776; member of the "Congress Committee," 1776; Freeholder and assistant Assessor, 1779; and member of the Town Committee, 1780-1785. He married ca. 1750 Eleanor Hunt born in 1728, youngest daughter of Edward Hunt of Maidenhead Township. Endorsed on the reverse side of Hunt's will is this: "April 8th 1758. Then received per the hand of Edward Hunt the just sum of fifteen pounds, being part of the within legacy bequeathed to my wife Eleanor. I say received by me, Henry Cook." The *New Jersey State Gazette*, Trenton, of 19 Nov. 1799, carried this item: "DIED. At Maidenhead, on Monday evening, 11th instant, Mrs. ELEANOR COOK, aged 71, consort of the late MR. HENRY COOK."

The will of Henry Cook of Maidenhead Township, Hunterdon County, dated 1 Oct. 1786 and proved 26 Nov. 1786, bequeaths to brother William Cook a tract of 50 acres; to son Samuel Cook 50 acres, "being the upper part of my plantation, whereon he now dwells"; to son Aaron Cook 50 acres "off the lower part of my farm, containing the mansion house, barn, etc., and to extend up the lane to two apple trees, and thence across the center of a spring of water, being a corner for William, Samuel and Aaron Cook"; the remaining 50 acres to be sold by the executors, and the money divided among my children viz. Elisha, Richard, Henry, Sarah, Abigail, William and Job; devises personal estate to wife Eleanor,

the livestock to be kept on that part of my plantation given to my son Aaron Cook; his mother is to live with him and be supported by him; to Elias Cook £50; to son Richard Cook 3 acres of the 50 given to my son Aaron; and appoints sons Elisha, Samuel and Henry executors; witnesses: Joseph Phillips, Robert Furman, Joseph Scudder. The original will has in the foregoing been followed--there is a brief digest in *N.J. Wills* 7:50. See also TAG, *supra*, 26:1-7; Edward Hunt's will is in *N.J. Wills* 3:170. The Elias Cook, legatee of £15 in the will, has not been identified, but it is found that he was born in 1769 in Maidenhead Township, died 22 June 1820 in Philadelphia, burial in Ronaldson's Cemetery there. His wife, Sarah (Roberts) Cook, died 9 Nov. 1833, aged 64, according to the gravestone. Their daughter Phebe Cook, born 3 Sept. 1797, died 11 July 1866 in Philadelphia, having married 2 April 1821, Thomas Porter Sherborne, a native of Queen Chariton Parish, Somersetshire, England, born 6 July 1798, died 20 May 1874 in Philadelphia, great-grandparents of Mr. Thomas H. Sherborne, Jr., of New York City, who reported this material to the present compiler in 1943. By deed of 1 April 1795, Richard Cook of Maidenhead Township and wife Anne conveyed to Henry Mershon the house and three acres of land in the southeast corner of the Henry Cook farm, reciting that "It is the same that was bequeathed to the said Richard Cook by his father, Henry Cook, late of Maidenhead, deceased," lying at the intersection of the two roads named in the will, being part of the 50 acres "off the lower part of my farm" which was bequeathed likewise to said Richard's brother Aaron Cook. By deed of 30 March 1801, sixteen months after the death of his widowed mother, Eleanor (Hunt) Cook, the said Aaron Cook and wife Elizabeth conveyed to Philip Hendrickson that 47 acres homestead part of his father's farm, and removed to Amwell Township, Hunterdon County.

One Elisha Cook witnessed the will of Dominicus Covenhoven of Windsor Township, Middlesex Co., N.J. 18 April 1778 (*N.J. Wills* 7:111). Joseph Story and Elisha Cook made inventory of the personal estate of Moses Groom of Windsor Township (*ibid.* 7:93), 24 Nov. 1786. Jonathan Rulon mortgaged a tract of 100 acres in that township to Elisha Cook, 12 Jan. 1791, who assigned the mortgage to Joseph Story three days later (*Middlesex Mortgages* 3:512 f.). Elisha Cook witnessed

the will of John Campbell of Trenton 7 March 1798 (*N.J. Wills* 9:58) but any mention of a wife or children has escaped recovery.

- iii. Richard, b. ca. 1757, d. intestate, West Windsor Township, Middlesex Co., N.J., shortly before 14 March 1808, date of inventory of personal estate, Benjamin Cook, administrator (*ibid.* 11:75). Richard Cook of Hunterdon Co. and Anne Atchley were married by N.J. lic. dated 13 May 1783, Samuel Cook as fellow-bondsman (*N.J. Archives* 22:73). Ann, wife of Richard Cook, d. 12 March 1849 in 84th year (g.s. Lawrenceville Presb. Churchyard). Orphans Court of April 1789 (Middlesex Deeds 3:526). Mary Groom gave bond of 1 Dec. 1786 as administratrix upon estate of Moses Groom of Windsor Township, decd, intestate, with Stacy Groom fellow-bondsman (*N.J. Wills* 7:93). Moses Groom of Middlesex Co. and Mary Brown of same were m. with N.J. Lic. dated 7 Feb. 1765 (*N.J. Archives* 22:160).

6. WILLIAM⁴ COOK, son of William³ Cook (Henry², Anthony¹) by his wife Hannah Phillips, was born 7 Sept. 1732 and died testate in Maidenhead Township, Hunterdon County, in 1802. By the will of his older brother, Henry Cook, in 1786, he received the southwestern 50 acres of the latter's plantation, fronting on the road leading from the Maidenhead old Great Road (King's Highway) to the Cross Keys tavern corner (now Evingville). William Cook by his will dated 4 Oct. 1784 and proved 25 March 1802 devised his real estate to his sons Enoch, Noah and Elijah Cook, the last named to provide for his mother and "all my youngest children until of full age"; son Noah to be put out to a trade when he arrives at the proper age; and appointed his wife Jemima and sons Enoch Cook and Elijah Cook executors. In a codicil of same date, he devised personal property to his daughters Susannah, Mary and Sarah, when they require a dividend thereof after giving my daughter Tabitha Rozell a cow and six sheep. The two first named executors renounced their appointment, and the the third, Elijah Cook, qualified as sole executor (abstract of original will, brief abstract in *N.J. Wills* 9:96). The maiden surname of the wife Jemima has not been recovered.

7. SAMUEL⁵ COOK, born in 1754, eldest son of Henry⁴ Cook (William³, Henry², Anthony¹) by his wife Eleanor Hunt, of Maidenhead Township, died testate in the adjacent Hopewell Township, 16 Jan. 1816, in his 63rd year, buried in the Pennington Presbyterian Churchyard (*Gen. Mag. N.J.* 42:133). He married about 1775 Prudence Lanning, born 1752, died 6 June 1839 aged 87 years, buried in same cemetery, daughter of Daniel Lanning of Trenton, now Ewing Township, said county (*N.J. Wills* 5:296; also Cooley, *Trenton and Ewing*, 158). Samuel Cook was a private in Capt. Nixon's Troop of Light Horse in the Middlesex County Militia (*Officers and Men of New Jersey in the Revolutionary War* 551). This reference supports the family tradition that Samuel Cook furnished his own horse and rifle in the Revolution. This service record has been accepted by both S.A.R. and D.A.R. in admitting descendants to membership. By his father's will of 1786, Samuel received the upper, northern, 50 acres of the homestead plantation, "whereon he now dwells," which was bounded on the southeast side of the road from the so-called "Federal City" projected site to Ewingville, along the Shabbacunck Creek, but he and his son Daniel Cook acquired from his uncle, Daniel Lanning and wife Susanna, the 140 acre farm across the road in Hopewell Township, on which farm they were then living, by deed of 1 May 1807, recorded in Hunterdon Deeds 13:458. The will of Samuel Cook of Hopewell Township dated 30 Nov. 1815, proved 4 March 1816, devises to wife Prudence Cook all household goods, the use of \$160 during widowhood; to grand-daughter Prudence Cook at age 18 \$160;

to grandson William S. Cook \$100 when of age; to son Daniel Cook all real and personal estate not before disposed of, he paying legacies of \$186 annually to his mother, Prudence Cook, during her widowhood, in lieu of her right of dower, if she choose to demand it, and he to pay unto his children, which he shall have by his present wife, \$2,666, thus: two shares to the sons and one share to the daughters, as each arrives to the age of 21 years; and appoints said son Daniel Cook executor (original will, brief digest in *N.J. Wills* 13:96). An account of this branch of the Cook family appears in F. B. Lee, *Genealogical and Personal Memorial of Mercer County, N.J.* (1907), pp. 519, 717.

DANIEL⁶ COOK, born 16 July 1780, only child of Samuel⁵ Cook (Henry⁴, William³, Henry², Anthony¹) by his wife Prudence Lanning, of Hopewell Township, Hunterdon County, died there, testate, on 20 July 1837, and was buried with his parents in the Pennington Presbyterian Churchyard. He was one of the Judges of the County Court of Common Pleas in 1806-1826; a Justice of the Peace, 1803-1832; and the Coroner in 1805. He was married by the Rev. Joseph Rue on 26 May 1804 to Keziah Smith, born 7 Oct. 1784, died testate, 19 Jan. 1866, at the home of her son Edmund B. Cook at Millstone, Somerset Co., N.J., buried with her husband, daughter of Joshua and Mary (Smith) Smith of Maidenhead Township. The will of Daniel Cook of Hopewell Township dated 11 Aug. 1836, proved 17 Aug. 1837, devises to wife Keziah \$1000, and orders his executors to pay her the \$440. left her by her mother's will; and devises to her also the use of one horse, two cows, a Dearborn wagon and harness, household and kitchen furniture, as his widow, also hay, grain, meat, etc., sufficient to keep herself and the younger children that may be at home with her, also necessities and clothing for one year after decease of testator, and in lieu of her right of dower, the yearly interest of \$22,000 as his widow; desires executors to pay unto his mother, for her support, in lieu of "what my father hath directed me to do for her, the yearly interest of \$3,000.00, and, if necessary, my estate to pay her funeral expences"; devises to daughter Prudence \$150, besides the book account against her and her husband; to each of my sons, Absalom P., Aaron H., Samuel B., George R., Jesse M., Lewis D., and Edmund B. Cook, \$500 when of age, or sooner if proper; also to them the legacy left by their grandfather, and the further sum of \$250 each in one year after my mother's death; to daughters Mary and Sarah Amanda \$600 each, besides what their grandfather hath left them, to be paid them at

age of 18 or marriage, and whatever they own; to Sarah Vaughn [an old and respected family servant who later lived with testator's daughter Prudence], \$20; "all my younger children should be brought up, clothed and schooled, until 15 years old, out of my estate, after taking the interest of their respective shares towards each one's, and when 15, or before, to put my sons out to trades: executors to sell all my lands and moveable estate that my wife does not take, and put \$3,000.00 out at interest for my mother's use as above named, and \$2,200.00 at interest for my wife, and the surplus money, if any, to be divided equally among my eleven children when Edmund is 15, after paying all debts and legacies above named"; and he appoints wife Keziah and son William S. Cook guardians of all the sons under 21 and the daughters under 18, and wife Keziah and sons William S. Cook and George R. Cook executors; witnesses: Nathaniel R. Hunt, Timothy Scott, Joseph Scott (original will has been abstracted). The old stone homestead of Samuel Cook, inherited and occupied by his only son Daniel, was destroyed by fire in 1856. The 140 acres plantation conveyed to them by the deed of 1 May 1807 from Daniel and Susanna Lanning, was bounded east by the Federal City road, east and north by the Lawrenceville-Pennington road, west by lands of Amos and Abijah Lanning and south by the 65 acre tract conveyed by Samuel Cook to his son Daniel by deed of 3 March 1806, all in Hopewell Township.

NATIONAL ARCHIVES ANNOUNCEMENT

From the General Services Administration which controls the National Archives and Records Service we have received in December 1971 the news that in the future reproductions of genealogical records will be made only if submitted on the proper forms which may be obtained from the Central Reference Division (NNC), National Archives and Record Service, Washington, D.C. 20408, and that it will no longer be necessary to send payment in advance. Long letters from querists require too much time to read, so henceforth obtain the proper form and supply only the information requested. If records are located, you will be billed for the necessary payment. These two changes are made in order to facilitate processing of inquiries, and much time will be saved. Here at least is one governmental regulation which ought to be received by the citizens with delight.
