The Smith Family of Bedford, N. Y., and Maidenhead, N. J.

LEWIS D. COOK, F.A.S.G.

JOHN SMITH, bricklayer, of New York City, purchased from Isaac Deschamps, merchant, of the same place, 17 March 1680, a two-acre home lot, a 40-acre farm lot, and four pieces of meadow, all in Bedford, in the Town of Brooklyn, Kings Co., L. I., N. Y., erected a house, and resided there at the time of his death in 1684. The hamlet of Bedford developed at the crossing of the highway east from Brooklyn Ferry to Jamaica with the road north from Flatbush to Newtown. Apparently, he was the "Jan Smit" who was assessed at one poll (head) £18, and one horse £12, in the "Valuation of Breucklyn, taken Sept. 26, 1683" (NYDH 2:502). From the fact that his will of 7 December 1683 named as guardians of his children Samuel Spicer and William Richardson, both Quakers (unlike Smith) and residents of Gravesend, L. I., but of no relation to him, he may be identified with the John Smith of Gravesend who bought plantation no. 35 there, 13 February 1660 and sold it to his "father-in-law" (stepfather) William Goulder, of the same place, 20 March 1665 (Bergen, *Early Settlers of Kings County, L. I.*, [hereafter BKCS] p. 266; GMNJ 29:49, 40:82, corrections). *

Although John¹ Smith of Bedford bequeathed his estate to his children by his will, but failed to name them therein, it is obvious that the Thomas² and Jasper² Smith who owned the same property and sold it in 1696 were his sons. Each of them named an eldest son John Smith. Thomas² Smith married Susannah Matthews of Jamaica, L. I., but he named his "father-in-law Ralph Hunt" co-executor of his will of 8 October 1702. Hence, it can be deduced that the Capt. Ralph Hunt of Jamaica, L. I., who also removed to Maidenhead, Hunterdon Co., N. J., by 1699, had married Susannah Smith, widow of this John Smith of Bedford, Kings County, L. I., before 1688, if indeed he left a widow.

By deed of 17 March 1680, Isaac Deschamps* of New York City, merchant, conveyed to John Smith of the same city, bricklayer, for £50, a two-acre home lot bounded north by the highway, east by Peter Palmatier, south and west by the common woods; also 40 acres of upland bounded north by Theunis Jansen, south by Peter Palmatier, east and west by the common woods; and four pieces of meadow, all in the town of Bedford in the West Riding of Yorkshire on Long Island, excepting on the west side of the home lot a piece of ground 80 feet wide and in depth from the north or front line of said lot to the rear thereof, all of which was formerly in the possession of Maillord Journy and Dirick Storme. (Acknowledged 14 March 1694/5 and recorded 19 March 1694/5 in Kings County Conveyances, Liber 2, page 47. The abstract published in the NYGBR 54:110 mistakes the date of recording for that of the deed.)

By deed of 20 March 1694/5, Isaac Deschamps of the city of New York, merchant, conveyed to Thomas Smith of Jamaica, Queens Co., Island of Nassau [L. I.], for ten shillings and "other good causes and considerations," a parcel of land in Bedford, Brooklyn Township, Island of Nassau, bounded west by a home lot formerly in possession of John Smith, Maillord Journy, and Dirick Storme, and now in possession of said Isaac Deschamps, 80 feet wide, on the west side of said lot, to extend in length from the north or front line of said lot to the south or rear thereof, which said home lot was formerly sold to one John Smith by said Isaac Deschamps by deed of 17 March 1680 (as above). (Recorded same date in Liber 2, page 49, whence this abstract.)

By deed of 20 October 1696, Thomas Smith and Jasper Smith, late of Bedford, Brooklyn Township, Kings County, Island of Nassau, conveyed to John Bibout of the same place, for £110, the house or home lot containing two acres, and the upland belonging to it, 40 acres, and the four parcels of meadow, with description the same as in the above deed of 17 March 1680. (Acknowledged and recorded 23 October 1696 in Liber 2, p. 106, whence this abstract; see also NYGBR 54:247.)

The will of John Smith of Bedford, Brooklyn, Kings Co., dated 7 December 1683 and proved 8 October 1684, leaves his estate to his children, not named, and appoints Samuel Spicer‡ and William Richardson† guardians and

* Isaac Deschamps, likewise known as Saviot or Sceviot Broussard, was in New York as early as 1674. In 1683 he bought a parcel of land in that city for Pierre Daille. He removed to Boston, but returned in or before 1686 to New York, where he made trouble in the French Church. His wife, whose name he seems to have assumed, was Mary Broussard. Deschamps was one of the settlers in Narragansett. His last abode was in New Rochelle, where Marie Broussard in 1709 sold land formerly belonging to him. His daughter married first Benjamin D'Harriette, and after his death, Andre Stuckey (Baird, *Hist. Huguenot Emigration*, 1885, 2:212).

administrators over the children, and Jan Damen, constable, Theunis Janse, and Daniel D. Rappalje, overseers (abstract in NYGBR 47:170.) The appraisal of the estate of "John Smith, deceased, lying in and about Bedford within the jurisdiction of the towne of Brewklin," made by Thomas Lambertse, Jan Gerrits, John Damen, Teunis Jansen, and Daniel Rappalie, 27 March 1685, listed 40 acres of upland, a two-acre meadow, a house lot with an house on it, all valued at £70; a mare with saddle £4; his clothing £8; bedding £25; wooden ware £2; tools and ironwork £13.13.0; brass and copper £7; pewter £3; tin wares etc. £3.3.0; a total of £145 (*Hist. Kings Co. & Brooklyn*, 1884, p. 420-a).

1. THOMAS² SMITH, born in or shortly before 1675, resided in Bedford Village, Town of Brooklyn. He removed thence with his younger brother Jasper Smith, as is evident from the Kings County deed of 1696 cited above, and they are found in Maidenhead Township, Burlington Co., N. J., by 1699, per deed evidence cited under No. 2 Jasper Smith. Thomas Smith died there in November 1702. He married Susannah Matthews, daughter of Samuel Matthews, Sr., of Jamaica, L. I. She died in 1695. (AG 25:72 and 33:124; NYGBR 65:120; NJA 21:531.)

The will of Thomas Smith of Maidenhead Township, Burlington Co., N. J., dated 8 October 1702 and proved 30 December 1702, names wife Suzannah, son John, daughter Suzannah, and an expected child; and appoints father-in-law Ralph Hunt, William Green, and William Hixson executors. The inventory of personal estate, made by Thomas Lambert, Joshua Wright, and John Bainbridge, and appraised at £324:9:6½, was dated 14 November 1702 (NJA 23:433). The "father-in-law Ralph Hunt," named a co-executor, was evidently Capt. Ralph Hunt who came from Jamaica, L. I., with wife Susannah, to Maidenhead, Burlington Co., N. J., by 1699, and died there testate in Jan-

NYGBR 47:227) was arrested and indicted as a Quaker there in 1661; was a magistrate 1687-1684; m. 21 May 1665, by Friends ceremony at Oyster Bay, L. I., Esther Tilton, dau. of John Tilton of Gravesend, who had been banished to Oyster Bay in 1663 for attending Quaker meetings. The births of the first 7 of 9 children of Samuel and Esther (Tilton) Spicer were recorded by N. Y. Monthly Meeting (*Encycl. American Quaker Genealogy*, 3:297; see also SHGM 5:131 and 292; and BKCS p. 242).

† William Richardson of Gravesend, Kings Co., L. I., in 1687, an active member of Society of Friends, died testate in Westchester, N. Y., in 1692 (Colls. N. Y. *Hist. Soc.*, 1898, p. 215). He had issue by 2nd wife Amy (who d. 5 Feb. 1683/4): William, b. 15 Jan. 1678/9 at the house of Matt Priors in Killingworth; Thomas, b. 10 Sept. 1680; and John, b. 10 Dec. 1683, d. in July 1688, per records of N. Y. Monthly Meeting, *Encycl. Amer. Quaker Gen.* 3:267; BKCS 269, NYGBR 3:188.

uary 1733, having married second one Elizabeth (—), who survived him and married Philip Phillips (*Ibid.*, 30:256). Apparently, Ralph Hunt married first Susannah Smith, widow, mother of Thomas Smith.

2. JASPER SMITH, born in or shortly before 1678, resided in Bedford village, Town of Brooklyn. He removed thence with his older brother Thomas Smith, as is evident from the Kings County deed of 1696 cited above, and they are found in Maidenhead Twp., Burlington Co., N. J., by 1699. (That township was included in the erection of Hunterdon County from Burlington in 1714.) Jasper Smith, Sr., freeholder, died in Maidenhead in March 1770, aged 92 years or more, having survived his wife, whose name escapes recovery here. He was commissioned a justice of the peace for the County of Hunterdon, 1719-1727 (PGM 8:64, 142, 150, 240) and in 1734, 1739, and 1749, but he petitioned to be dismissed from the commission on 21 December 1757 (NJA 15:98; 16:91; 17:137).

The names of Thomas Smith and Jasper Smith are the ninth and tenth of the 28 grantees, all of Maidenhead, in the deed of 18 March 1698/9 by which the West Jersey Society conveyed to them a tract of 100 acres there on which to erect a meeting house and school house and to provide a burying ground (NJA 21:517, abstract; *Rev. John Moore of Newtown, L. I.*, p. 423, for transcript in full).

By deed of 18 December 1710, Jasper Smith of Maidenhead, yeoman, conveyed to Richard Furman of Newtown, Queens Co., L. I., yeoman, for £60 silver money, a tract of 100 acres in Hopewell, said county, bounded southwest by Ralph Hunt and John Bainbridge, northwest by Richard Hall, north by Rehoboth Gannett, and southeast by Five Mile Run and Arthur Kyrk, which was sold by Thomas Revell, agent for the West Jersey Society, to said Jasper Smith (West Jersey Deed Book 0:363).

By deed of 22 July 1740, Jasper Smith, Sr., of Maidenhead, yeoman, conveyed to Jasper Smith, Jr., "son of the said Jasper Smith, Sr.," tracts of 150 and 25 acres in Maidenhead, with the houses etc., beginning at an oak tree on the south side of Five Mile Run, in the line of Benjamin Brearley, thence along his line and that of Matthew Roger to the corner of Thomas Smith, thence along his line to a tree near said run, thence down said run to a maple tree on its north side; thence along said Jasper Smith, Sr.'s line to a maple sapling on the north side of said run, thence down said run to the place of beginning, 150 acres. The witnesses were John Smith, Joshua Smith, and Joseph Yard, which last-named attested the signature of the grantor on

17 February 1759, and the deed was recorded on 9 October following in West Jersey Deed Book P:152.

The will of Jasper Smith of Maidenhead Township, Hunterdon Co., N. J., freeholder, dated 29 November 1769 and proved 11 April 1770, devises to eldest son John the plantation on which he now dwells; to grandson Waters Smith the plantation whereon his father, my second son Jasper Smith, dwelled when he died; to third son Thomas the plantation where he lives; to fourth son Samuel 20 shillings; to grandson John Smith, fourth son of my son Samuel, 100 acres from the plantation whereon I live, to be on the east side of the road from Trenton to Princeton, said grandson to maintain his mother Elizabeth Smith, his father's wife; to grandson Jasper, second son of my son John, 2 acres of meadow adjoining the widow Hunt's lot; to my youngest son Joshua the rest of the plantation whereon I live, he to pay to my son Ralph, his brother, £100; and the moveable estate to my sons Samuel, Ralph, and Joshua; and appoints son Ralph and grandson Waters Smith executors (abstract of original will). Waters Smith renounced executorship on 9 April 1770 in writing witnessed by Israel Smith and Jean Smith. Ralph Smith also renounced in writing on 7 April 1770, witnessed by John Biles and Samuel Smith, whereupon Joshua Smith was appointed administrator. He gave bond dated 15 June 1770, and filed the account dated 23 March 1772 (NJA 33:394). The signature of Joshua Smith, adminr., on his bond is identical with that of Joshua Smith of Oxford Township, Sussex Co., N. J., whose will was dated 4 September 1777. The other son, Ralph Smith, evidently renounced executorship by reason of his removal from Maidenhead to Hanover, Morris Co., N. J.

3. JOHN³ SMITH, born in 1699 in Maidenhead Township, died there on 19 April 1748, aged 49 years, per gravestone inscription in the Upper Burying Ground at the northeast end of the village of Lawrenceville, formerly Maidenhead. John Smith and Hannah his wife were admitted to membership in the Presbyterian Church of Maidenhead on 12 September 1734. Although John Smith names his "brother-in-law William Waters" an executor (see below), it is found that the latter had an only sister Elizabeth Waters, who was born in 1722 and died 29 December 1771, first wife of Andrew Muirhead of Hopewell Township (NJA 33:466 and 467). But Mary, wife of William Waters, was admitted to membership in the Presbyterian Church of Hope-

well on 19 August 1735. Her surname has not been recovered here, but she may have been sister to Hannah, wife of John Smith, which would explain the fraternity of their husbands.

The will of John Smith of Maidenhead, yeoman, dated 1 March 1747/8 and proved 4 May 1748, names wife Hannah; bequeaths to son John the plantation when he is of age, at which time testator's wife is to remove to the house and plantation on the west side of Five Mile Run; to son Thomas, when of age, the said latter plantation; devises to daughters Mary, Elizabeth, Susannah, Hannah, Sarah, and Priscilla; and appoints brother-in-law William Waters and John Ely, Senr., of Maidenhead, executors. Witnesses: Joshua Smith, William Ball, Peter Verdal (NJA 30:441.)

6. JOHN³ SMITH, born in say 1699, eldest son of Jasper Smith of Maidenhead Township, died there intestate in November 1779; Isabel Smith, widow,* and [her brother] Joseph Tindall of Trenton Township, said county, gave bond as administrators, 22 November 1779, with their brothers-in-law John Phillips and Nathaniel Temple as witnesses (NJA 34:478).

7. JASPER³ SMITH, JR., second son of Jasper Smith, Sr., of Maidenhead Twp., born in 1701, died there 19 September 1754 in his 54th year, per gravestone inscription in the Upper Burying Ground, Lawrenceville. His widow Keziah Smith and eldest son Waters Smith gave bond as administrators on his estate, 11 September 1754, with Thomas Stevens as fellow bondsman, all of Maidenhead (NJA 32:199).

Jasper Smith, Jr., married about 1725 Keziah Smith, daughter of "Mr." Thomas Smith of Jamaica, L. I.† She died 2 November 1779, aged 77 years,

8. THOMAS³ SMITH, born say 1703, third son of Jasper Smith, Sr., of Maidenhead Township, died after 1769, the year of his father's will, in which he was named a devisee; but his estate is not found in the county probate records, and the year of his death is not recovered here. He may have removed from Maidenhead to Morris County, N. J., as did his brother Ralph. But there is no evidence of that, other than the fact that his son James Smith resided in or near Morristown in the period 1772-1785, according to the register of the First Presbyterian Church there. The will of Elizabeth (Hazard) Hunt, second wife and widow of Edward Hunt of Newtown, Queens Co., N. Y., dated 3 September 1747, devises to her daughter Hannah, wife of Thomas Smith of New Jersey, her Negro wench Dinah, and the residue of her estate to her grandchildren, not by names, the children of her daughter Hannah, and of her son Jonathan (AG 26:7). Hannah (Hunt) Smith died 17 August 1759, aged 47 years, per gravestone in the Upper Burying Ground, Lawrenceville. A family record states that she was born 21 March 1709, and died 8 August 1759 (*Genealogy & History*, 1940, no. 1791).

10. RALPH³ SMITH, fifth son of Jasper Smith, Sr., of Maidenhead Township, died in July 1784 in Hanover Township, Morris County, N. J. His

widow, Rachel (Anderson) Smith, died there intestate in September 1805 (NJA 39:414).

Ralph Smith married Rachel, daughter of Enoch and Catherine (Opdyck) Anderson of Trenton Township, Hunterdon County, N. J. (GMNJ 21:43; NJA 30:21). By deed of 28 December 1743, Enoch Anderson [Jr.], of Trenton, mercht., Benjamin Stevens of Maidenhead, yeoman, and wife Sarah; and Ralph Smith of Maidenhead, and wife Rachel, conveyed to Catherine Bonham of Trenton, five lots of land, with recital that Enoch Anderson, late of Trenton, deceased, by his will of 2 October 1741 devised the residue of his estate equally between his son Enoch and daughters Catherine, Sarah, and Rachel (recorded 6 August 1756, West Jersey Deed Book N:187).

The will of Ralph Smith, of Hanover, Morris Co., N. J., dated 16 September 1783 and proved 15 July 1784, bequeaths to wife Rachel the ten acres bought of the estate of Dr. Thomas Budd; to son Jasper the bond I have against him; to daughter Catherine Cheevers £125; to daughter Sarah Lewis £125; to grandson William Ames Smith the house where I live and 50 acres, or if he dies under age, to grandson Ralph, son of Jasper Smith; to grandson Charles Smith 50 acres, he to pay the legacies to my two daughters; to grandsons William Melville Smith and Ralph Smith, sons of Jasper, the rest of my lands, excepting eight acres to my grandson Charles Smith; and appoints wife Rachel, son Jasper, and Aaron Kitchell executors (NJA 35:362).

11. JOSHUA³ SMITH, sixth and youngest son of Jasper Smith, Sr., of Maidenhead Township, was baptized there on 22 June 1714 by the Presbyterian minister from Philadelphia (PGM 19:282). He died in August 1784, in Oxford Township, Sussex Co., N. J.

His wife, Keziah Pelton, daughter of Benjamin and Keziah Pelton of Huntington, L. I.; and of Hopewell, Hunterdon Co., N. J., was baptized 19 October 1729 in Huntington, and died after the date of his will of 1777. (Corrections of the *Pelton Family in America*, 1892, page 543, which states that Keziah Pelton married one *Platt* Smith, are published in *American Genealogist*, 40:100.)

The will of Joshua Smith of the town of Oxford, Sussex Co., N. J., dated 4 September 1777 and proved 3 November 1784, devises to wife Keziah Smith the best feather bed, etc., with my Negro wench Juda, wife of my Negro man Prince, and a bay mare that came by her father's legacy; orders his lands to be sold within six years from his decease, my son Joshua to have an equal share and benefit of working said lands until sold; devises to said son Joshua Smith £70 after the sale of lands; to son Jasper Smith £100 likewise, and the remainder of the money divided among my children, namely Plat Smith, Benjamin Smith, Obadiah Smith, Annanias Smith, and Keziah Smith my youngest daughter, as they come of age or at marriage; to my oldest daughter Christian Biles my Negro girl Pegg; to my daughter Mary Smith my Negro girl Deborough now living with her; and appoints his wife Keziah Smith and son-in-law John Biles executors (digest of the original will; compare brief abstract in NJA 35:361, which includes the inventory of personal estate dated 3 September 1784). The *Pelton Family* states (page 543) that the sons Obadiah, Annanias, and Platt, or most of them, removed to Tompkins County, N. Y., about 1797-1800.

12. JOHN⁴ SMITH, born about 1735, described as under 21 in the will of his father, John Smith, in 1748, died in December 1769. His widow, Rachel Smith, whose maiden surname has escaped discovery here, was born 2 June 1738, per Bible records, and as Rachel Mershon, died 20 November 1830, aged 93 years, per obituary in the *New Jersey State Gazette*. As Rachel Smith, widow, she had married secondly William McCoy of Maidenhead Township,* who died intestate, and as Rachel McCoy, she and her son Philip Smith gave bond on 25 February 1785 as administrators upon his estate (NJA 35:262). She married third, as his second wife, Henry Mershon, also of Maidenhead Township, who was born January 27, 1734, per Bible records, and died 5 November 1814 in his 81st year, per obituary in the *Trenton Federalist*. The will of John Smith, of Maidenhead Township, dated 14 November 1769 and proved 20 December 1769, names wife Rachel; five children—Jonathan, Philip, Enoch, Sarah, and Isaiah, all under age; also niece Sarah Hunt; and appoints his wife Rachel and friends Philip Palmer and Nathan Hunt executors. The inventory of his personal estate was made on 7 December 1769 (NJA 33:395).

13. THOMAS⁴ SMITH, born 25 May 1743, son of John and Hannah Smith, of Maidenhead Township, died 18 October 1799, in Freehold Township, Monmouth County, N. J.

He married with license dated 25 January 1764, Sarah Green, who was born 19 August 1744, daughter of Joseph and Elizabeth (Mershon) Green, and died 15 November 1801, per Bible records. The will of Joseph Green, of Trenton Township, Hunterdon County, N. J., dated 12 February 1776, bequeathed lands in Nottingham Township, Burlington County, N. J., to his daughter Sarah, wife of Thomas Smith (NJA 35:166). "Thomas Smith, son of John, and grandson of Thomas, a family settling early between Maidenhead and Trenton. Thomas and Sarah left their ancestral neighborhood, and moved to a farm on what is now (1940) State Route no. 33, about two and one-half miles west of Freehold, owned by the Orr family" (*Our Pioneers, Mershon*, 1957, p. 59).

The will of Thomas Smith, of Freehold, Monmouth County, N. J., dated 13 October 1799 and proved 25 November 1799, provides for his wife Sarah and daughters Hannah and Nancy Smith to be maintained on the place by his son John Smith, to whom he bequeaths the farm and all personal estate, he to make all payments to the other devisees; to daughters Hannah and Nancy £50 each when they marry; to son Waters Smith £25 on demand; to daughter Rebecca Morris £25 and appoints his wife Sarah and son

John Smith executors (NJA 38:337).

The will of John Smith of Maidenhead, dated 30 August 1812 and proved 9 October 1812, orders the sale of all estate except as here devised; after payment of debts, devises one-third of the residue to wife Catharine Smith during her lifetime, and two-thirds equally divided among my sons and daughters (not named), except my son Jasper to have two shares; and appoints sons-in-law Nathan Fish and Benjamin Smith executors. The inventory of personal property was appraised at \$813.47 on 1 October 1812. (From the original will; brief abstract in NJA 41:346.) Catherine, widow of John Smith, died 2 February 1834, aged about 90 years (gravestone in Presbyterian Churchyard, Lawrenceville).

Jemima, "consort of Jasper Smith," died 28 August 1836, in 93rd year (gravestone).

"Jemima," daughter of Daniel Lanning of Ewingville, "married Jasper Smith of Lawrenceville, and had issue: Daniel, graduated at Princeton, a lawyer, resided in Sunbury, Pa.; Asher lived in the homestead; Hannah married Daniel Clark; Sarah married Elias Scudder; Elizabeth married Richard Hill; Jasper died 1832; and Prudence married first William Mershon and second Joseph Patterson, who died 1838 aged 58, by whom she had Mary, wife of Dr. Allison Perrine of Monmouth Co., she died in 1867 aged 90"

(CSTE, page 158, which omits the son Enoch Smith, named in his father's 1817 will as deceased, and substitutes a son Jasper Smith as died in 1832, who is not named in the will). The will of Daniel Lanning of Trenton Township, dated 30 October 1771, as abstracted in NJA 34:296, does not name a daughter Jemima.

The will of Jasper Smith of Lawrence Township, dated 7 May 1817 and proved 4 May 1820, devises to wife Jemima; to grandson Charles Clark \$150.00; to son Asher Smith; to daughters Hannah Clarke, Sarah Scudder, and Elizabeth Hill; to son Asher's daughters (not named); to daughter Prudence Patterson; to grandson Samuel Mershon; to son Enoch's children (not named); and appoints his wife Jemima Smith, son-in-law Richard Hill, and nephew Daniel Cook, the executors. Witnesses: Prudence Cook, Daniel Lanning, William Wilgus. (Digest of original will.) The account of this Jasper Smith in the *History of Burlington and Mercer Counties*, 1883, page 847, confuses him with No. 24 Jasper Smith.

JOSHUA⁴ SMITH, born in 1745, third son of No. 6 John and Isabel (Tindall) Smith of Maidenhead Township, died there in November 1785, in his 41st year, per gravestone inscription in the Upper Burying Ground at Lawrenceville. He married his first cousin, Mary Smith (No. 40), daughter of Joshua and Keziah (Pelton) Smith of Maidenhead and of Oxford Township, Sussex Co., N. J. She married second Samuel Baker of Hopewell Township, and died there 9 October 1834 in her 83rd year, per gravestone inscription ("widow of Joshua Smith," her previous husband), in the Upper Burying Ground.

The will of Joshua Smith of Maidenhead, Hunterdon Co., N. J., dated 14 November 1785 and proved 4 February 1786, bequeaths to wife Mary all his lands and plantation "whereon I now live," while my widow; to my two sons William and George Smith my plantation equally divided, after the marriage or death of my widow; to my three daughters, Sarah, Matilda, and Kezia, £50 each at marriage or at age 20, or to their survivors; my Negro girl Debb shall be at the disposal of my wife. It orders £100 to be put out at interest for the yearly expenses of the family, and the profits of the plantation to provide for and bring up "my children, my sons William and George to have sufficient schooling and to be put out to trades at a convenient age." Executors: wife and "my loving brother Jasper Smith," and friend Joseph Brearley. Witnesses: Timothy Baker, Samuel Baker, Job Pearson. Inventory of personal estate, 7 December 1785, appraised at £347-9-8 by Christopher Howell and Job Pearson, including "One negro girl called Debb" at \$50.00. (Digest of original will; brief abstract in NJA 35:361. Notice that the Negro girl Debb was evidently the "Deborough" devised by No. 11 Joshua Smith to his "daughter Mary Smith, now living with her," in his will of 4 September 1777.)

The will of Mary Baker, of Hopewell Township, dated 4 October 1832 and proved 28 October 1834, devises to my two sons William and George Smith all monies due me from them; to my grand-daughter Mary Cook my bedstead etc.; to my grand-daughter Matilda Ketcham my bed etc.; to grand-daughter Louisa Ketcham my bed, etc., which I lent to my daughter Matilda in her lifetime; the residue of estate to be divided, one-half to my daughter Matilda's children, Matilda, Louisa, and Henrietta, each \$100, or if they die, then to my daughter Matilda's sons, Henrietta's share to be put out to interest until she is 18 or married; and the residue of that half to be paid to my daughter Matilda's son Joshua, he to divide it with his brothers if living

at my decease, and put their shares out at interest until they are of age. The other half of my estate to my daughter Keziah, o have the use of it during her life, and at her decease the remainder of it to be equally divided between her children then living. Son-in-law Daniel Cook sole executor. Inventory of the personal estate, by Enoch Ketcham and William S. Cook, appraised at \$1,1040.27 (Digest of original will.)

22a. ELIZABETH⁴ SMITH is assigned here as a daughter of No. 6 John and Isabel (Tindall) Smith of Maidenhead Twp., by deductions from the statement in Cooley, *Trenton and Ewing*, 1883, page 155, that Ralph Lanning "married first Elizabeth, sister of Jasper Smith, and second Mary, daughter of Amos Hart," and the fact that he had an eldest son named Jasper Lan-

ning. The order of his wives as stated seems to be in reverse, as his will names wife Elizabeth, not Mary. Ralph Lanning was born in 1723, son of Robert and Martha (Hart) Lanning, Jr., of Trenton Township. He died in Hopewell Township in December 1800, aged 77 years, per gravestone inscribed also "R.L." in the Presbyterian Churchyard, Ewing Township.

The will of Ralph Lanning, Sr., of Hopewell Township, dated 24 June 1798 and proved 31 January 1801, devises his estate to wife Elizabeth; to sister Martha, widow of John Phillips; to sons Amos and Daniel the lands they live on; to grandsons Abijah Lanning and Ralph Reed £10 each; to son Noah the remainder of lands, the wagon, plow and harness, he paying to his brother Ralph £50; to daughters Elizabeth Cornell and Mercy Reed £50 each; and appoints son Amos Lanning and son-in-law William Cornell executors (NJA 39:266). Ralph Lanning was a second lieutenant in Capt. Hunt's Company, First Regiment of Hunterdon County Militia, scout and guide to General Washington (*Officers and Men of N. J. in the Revolution*, page 445).

23. WATERS⁴ SMITH, born in 1732, eldest son of No. 7 Jasper and Keziah (Smith) Smith of Maidenhead Township, N. J., died there without issue on 17 August 1820, aged 88 years and 7 months per gravestone in the Upper Burying Ground, in Lawrenceville. "Died. In Lawrence, on the 17th of August, Waters Smith, in the 88th year of his age. He was an elder in the

church for nearly half a century. His funeral was unusually large and solemn" (*Trenton Federalist*, 11 Sept. 1820). Waters Smith was elected a freeholder of Maidenhead Township in 1764, 1766, and 1770. He married first, with a license of 17 January 1770, Jane Van Cleve, daughter of John and Sarah (Couwenhoven) Van Cleve of Maidenhead Township (NJA 22:376, 34:536, 537). Jane, wife of Waters Smith, died 23 March 1809, aged 65 years, per gravestone with his. (These dates correct those in CSTE, p. 292.) Waters Smith married second Lammetje (Bergen) Couwenhoven, widow of Garret Couwenhoven of Dutch Neck, Windsor Twp., N. J., who had died there intestate in November 1785. She was born 9 April 1758, daughter of George and Maria (Probasco) Bergen of Windsor Township, and died after 30 August 1817, the date of Waters Smith's will (NYGBR 82:214; *The Bergen Family*, 1876, No. 436; NJA 35:97).

The will of Waters Smith, Senr., of Lawrenceville, dated 30 August 1817 and proved 7 September 1820, bequeaths to nephew Waters Smith, Junr., a 6- or 7-acre woodlot east of a 4-rail fence south of my orchard, on the Branch Turnpike Road, bounded by the land of James Smith decd., by Five Mile Run or Brook; also a 100-acre tract east of said woodlot, on the Branch Turnpike Road and Five Mile Run, bounded by land I bought of my brother Israel Smith, Senr., and by that of Joseph Van Cleve, near my bridge, with all the improvements, with half the cattle, hogs, and sheep, all my horses, my wagon, gears, plows, harrows, and cider mill; also a 4-acre lot in the Great Meadow, lying by Israel Steven's lot. To my brother Benjamin Smith an 8-acre woodlot at the far end of my place, next to Temple's and between Major Mershon's and William Biles' lots. To Waters Smith, Jr., a 4-acre woodlot next to Benjamin Smith, Esquire's, lot of 8 acres. To John Stevens, Thomas and Israel Stevens, Benjamin Smith, Junr., and Israel Smith, Junr., my five nephews, all the remainder of my land; that is, the land lying south of a 4-rail fence and the woodlot given to Waters Smith, Junr.; my 7-acre lot in the Great Meadow to be sold, and the money divided between my five nephews named above, they to subscribe \$20.00 each towards enclosing the Upper Burying Ground, commonly called, up by Samuel Hunt's, with a fence or a stone wall. Orders that Waters Smith, Junr., shall pay Samuel Smith, son of Benjamin Smith, Junr., \$200 proclamation money in three years after my decease, as a legacy, out of the land given him. Orders John Stevens, Thomas and Israel Stevens to pay their mother Catharine Stevens £100 equally between them in one year after my decease, as a legacy, out of the land given them. Orders Benjamin Smith, Junr., and Israel Smith, Junr., to pay their father, Israel Smith, Senr., \$100 in one year after my decease, as a legacy, out of the land given them. To my wife Lamathey Smith, the possession of certain rooms we now live in, "all the goods which she brought with her when she moved to my house," a Negro girl Sarah Bristor, the use of furniture, glasses, dishes, bedding, while my widow, and possession of a horse, riding chair, and a cow, as also \$650, the 6 large silver table spoons marked W.L.S. and the 6 silver

tea spoons marked W.L.S.; Waters Smith, Junr., to deliver wheat, beef, firewood, etc., every year as long as she remains my widow. To the two daughters of Elizabeth Breyrley, deceased, \$100 each if they arrive at 18 years, otherwise to be divided among my five nephews named above, and to them the residue of movable estate. Appoints two nephews, namely Israel Stevens and Waters Smith, Junior, executors, "trusting that no one will be dissatisfied of my estate, as I have endeavored to satisfy my relations as I thought best." Witnesses: Isaac Brearley, Sarah Brearley, Johnes Brearley.

24. JASPER⁴ SMITH, Esq., born in 1737, second son of No. 7 Jasper and Keziah (Smith) Smith of Maidenhead Township, died there, without issue on 5 October 1813 aged 77 years, "Counsellor at Law," per gravestone inscription in the Upper Burying Ground, Lawrenceville. For a separate account of his life, see the present compiler's article in GMNJ, January 1971.

ISRAEL⁴ SMITH, born in 1738, third son of No. 7 Jasper and Keziah (Smith) Smith of Maidenhead Township, died there, "very suddenly," 1 July 1818, in the 80th year of his age, per item in *Trenton Federalist*. No gravestone is found in Lawrenceville, where he had a life interest in a plantation of his brother Jasper Smith, No. 24. Israel Smith married by 1763 Johanna Hill, daughter of Samuel Hill of Nottingham Twp., Burlington Co., N. J., who died in 1785.* "Mrs. Israel Smith, widow of Mr. Israel Smith, died in Lawrence Township on 16 August 1819" (*Trenton True American*, 23 August 1819). The will of No. 23 Waters Smith names Israel Smith's children (below) as nephews and nieces.

CATHERINE⁴ SMITH, daughter of No. 7 Jasper and Keziah (Smith) Smith of Maidenhead Township, named as sister in the will of No. 24 Jasper Smith, dated 8 January 1811, and in that of No. 23 Waters Smith, dated 30 August 1817, as Catherine Stevens, and as having sons John, Thomas, and Israel Stevens, was born about 1738 and died after 1817. She married in or before 1756, Thomas Stevens, who was born about 1735 and died in Maidenhead Township, in July 1777. The will of George W. Smith, of Philadelphia, dated 20 April 1848 and proved 26 July 1848, bequeaths to his wife Elizabeth the use and income of his house and lot in South Camden, N. J., during her lifetime, as also the mortgage held against son George's property, 184 North 2nd Street in the Northern Liberties of Phila. To sons William, George W., and Henry H. Smith, the balance of real and personal estate, \$500 to be deducted from son William's share, which was lent him when he purchased his house in Norristown, Pa. To son Henry H. Smith, the building and lot, 175 North 2nd Street, valued at \$9,000, he to pay two other sons William and George W. Smith \$3,000 each. Appoints as executor son William Smith, who qualified at the probate, signing his name and "Norristown, Pa."

Benjamin Smith, Jr., served as town clerk of Lawrence, 1804-1825. Mary Smith, wife of Benjamin, was admitted to membership in the Presbyterian Church of Lawrenceville on examination on 14 May 1807. She was apparently a daughter of No. 20 John Smith.

The will of Benjamin Smith, of Lawrence Township, Hunterdon Co., N. J., dated 12 November 1825 and proved 10 January 1826, devises to son Samuel H. Smith and daughter Theodosia the house and lot on the Branch Turnpike between Trenton and Princeton in trust for bringing up the other children, not named; devises also to son Jasper B. Smith, daughters Elizabeth, Jane, and Lamatta Ann; and appoints brother Waters Smith and son Samuel H. Smith executors. Witnesses: Israel Smith, Maria Smith, Catherine J. Smith (digest of original will).

From a comparison of this with the sketch already printed (pages 58-59 of this volume) the following *addenda et corrigenda* have been compiled: Thomas Smith died 17 (not 18) October 1799; he and his wife are buried, with four children, in Old Tennent churchyard (inscriptions in F. R. Symmes, *Hist. of Old Tennent Church*, 1904, pp. 265, 276). Of the children, Hannah (46a) d. 12 Aug. 1803, unm.; Watters (46c) d. 23 Mar. 1849 in Harrison Co., West Va., m. abt. 1793 (his son Charles Smith, b. 13 Nov. 1796, d. 13 June 1877, m. 22 Jan. 1823 Mary Grant, b. 27 July 1804, d. 22 May 1879); Rebecca (46d) m. 20 Jan. 1796 Samuel Morris, and they removed from Monmouth Co., N. J., to West Va. in 1818; Nancy (46e) d. 8 Sep. 1809, unm.; John T. (46f) d. 30 Apr. 1846, Monmouth Co., N. J.; Joseph (46h) is indeed named in his father's 1799 will, not "unnamed" as in the account printed on page 59. The same will (of Thomas, 1799), incidentally, named Hannah and Nancy as daughters 'who live with me.'
