### DESCENDANTS OF RICHARD AND MARGARET HAINES

Richard Haines was the progenitor of the Haines family of Burlington County, New Jersey. Very little is known about him or his life in England. The first record of him is found in Parish Records of St. Michael's Church, Ayfhoe, Northamptonshire, when his son Richard was baptized on August 6, 1665. Sometime previous to this date he had married his wife Margaret, and they had had at least one other child, John. These events probably did not take place in Aynhoe, as no record of them can be found in the Parish Records. It seems likely that Richard and Margaret located in Aynhoe shortly before the baptism of their son Richard, and before then had lived in one of the neighboring parishes. However, they continued to live in Aynhoe until leaving for America, as is evidenced by the baptism of two of their sons in 1666 and 1672; by the record of the birth of their daughter Mary in 1676, Banbury MM, Oxfordshire, when his residence was given as Aynhoe; and by the deed dated April 21, 1682, in which his residence was given as Aynhoe.

It is not known what variation of the Haynes-Haines name Richard used in England. The records of St. Michael's church show his name as Hains and Haynes. The records of Banbury MM show his name as Haynes. The deed record shows his name as Haines. Some of the early records in America show the name as Haynes. But these variations in spelling may be due to the persons actually writing the records and might not reflect the spelling of the name as used by Richard. It is significant, though, that all known descendants of Richard have used the spelling Haines, and continue to do so until this day.

Richard and Margaret Haines became members of the Society of Friends sometime during the period 1672-1676. It seems likely that this religious association had some bearing on the decision of Richard Haines, and of John Borton, his fellow townsman, to emigrate from England to America, and undoubtedly it was a contributory factor in deciding where to settle in America.

Richard and Margaret Haines, with their children Richard, Thomas, William and Mary, left Aynhoe of ye Hill in the spring of 1682. They embarked at Gravesend, England, on the 'Amity' — Richard Diamond, Master — and sailed from Downs, England, for West Jersey, on April 23, 1682. The trip was long and tedious, as was common in the days of sailing ships. Richard, the father, sickened and died. After his death, another son, Joseph, was born on the high seas.

John Haines, oldest son of Richard and Margaret Haines, preceded his parents to America. He accompanied John Borton and family, also of Aynhoe, to America in 1679, and was undoubtedly instrumental in deciding his parents to leave England for America.

In about, two and one-half years, on 3 mo. (May) 6, 1685, at Thomas Gardiner's house, Burlington, under the care of Burlington MM, N. J., she married Henry Burcham, of Neshamony, Bucks Co., Pa.

Richard Haines had not made the decision to leave England without making provision for a livelihood in America. West Jersey, through the influence of William Penn and others, was being settled largely by members of the Society of Friends. Richard Haines was a farmer, or "husbandman," and a man of some means, as he was able to purchase land before leaving for America. He purchased 100 acres of land from Edward Byllynge, recorded as follows: "1682 April 21. Deed. Edward Bylling, late of Westminster, gent: to Richard Haines of Anve of ye Hill, Co. of Oxon, husbandman, for 100 acres in West Jersey." [Ref: Richard Haines — Haines Ancestry, p. 8. November 1728; m. 1st, at Thomas Gardiner's house, Burlington; under the care of Burlington MM, N.J., 10 mo. (Dec.) 10, 1684, Esther Borton, b. England, 5 mo. (July) 25, 1667; d. 1719; daughter of John and Ann (Kinton) Borton. He is said to have accompanied John Borton and his family to America in the "Griffin" in 1679; to have lived at first in a cave in 'Haines Bank' on the South branch of the Rancocas Creek below Lumberton, N.J.

John Haines gradually became the owner of many acres of land in New Jersey and Pennsylvania. The first recorded survey of land was dated 11 mo. (Jan.) 1683, an abstract of which follows: "Memorandum of survey for John Haynes one parcell of land abutting on the South side of the South Branch of Northampton River and from a white oak thereby marked it runs S.W. 80 chains (1 mile) to a white oak for a second corner, then N.W. 25 chains to a black oak for a third corner, then N.E. to said river." Surveyed for 200 acres. He also located 50 and 100 acres of land in 1691. In 1687 he purchased 100 acres of land from Percival Towle; in 1693 200 acres of land from the executors of Thomas Ollive and 200 acres of land from Samuel Jennings; in 1694 85 acres of land from his brother Thomas; in 1702 965 acres of land in Goshen, Chester Co., Pa., including that part of West Chester, Pa., south of Gay St.; in 1710 254 acres of land in Chester Co.; and, along with Richard Haines, William Haines, Thomas Wilkins, John Borton, Benjamin Moore and Jonathan Haines, 2240 acres of farm and wood land in the Southern Part of New Jersey known as the "Friendship Tract" in 1711.

His will was dated November 4, 1728, and was probated Nov. 21, 1728. An inventory of his personal property was taken on November 14, 1728. [Ref:

John Haines m. 2d, Woodbury Mtg., under the care of Haddonfield MM, N.J., 1722, Hannah Whitall Wood, widow of James Whitall and Henry Wood. First intentions of marriage were declared at Haddonfield MM during 2 mo. (Apr.) 1722 and the marriage probably took place less than two months later. After becoming a widow for the 3d time, she returned to Gloucester Co., N.J. Her will was dated Dec. 5, 1731, and was affirmed Dec. 26, 1732. An inventory of her personal property was taken on Nov. 29, 1732.

(1) Richard<sup>2</sup>-Haines (Richard<sup>1</sup>) farmer, of Evesham Twp., Burlington Co., N.J. bapt. St. Michael's Church, Aynhoe, Northamptonshire, England, Aug. 6, 1665; d. 1746; m. Mary Carlile, said to have been an Indian maiden, and also said to have been born in London, 5 mo. (July) 20, 1674; daughter of John and Mary (Goodwin) Carlile. Since the identity of Mary Carlile has caused much controversy, this subject will be discussed more fully elsewhere in this volume. The date of their marriage is also uncertain. In the Haines Ancestry it is stated that the marriage took place in 1699. In Virkus the date is given as 1691. Since no record of a marriage has ever been found, it is difficult to establish a date. However, Richard and Mary Haines were witnesses to the marriage of Francis Austin and Mary Borton on 7 mo. (Sept.) 15, 1696, at Friends' Meeting, Haddonfield.

Richard Haines located 100 acres of land in 1688; he purchased 100 acres of land from Elias and John Burling in 1693; 100 acres of land from Thomas Haines in 1695 and 100 acres of land from Francis Collins in 1700. He was one of the purchasers of the "Friendship Tract," 2240 acres of farm and wood land in the Southern Part of New Jersey, in 1711. His will was dated Dec. 17, 1744, and was probated Apr. 12, 1746. An inventory of his personal property was taken on 2 mo. (Apr.) 11, 1746. He named his wife Mary and his daughter, Elizabeth Newbury, as executors, but the will was probated by Elizabeth Newbury, surviving executrix, which places the death of Mary Haines between Dec. 17, 1744, and Apr. 12, 1746.

A record of the dates of birth of the children of Richard and Mary Haines has not been found. The order of birth is not certain either, but it is believed that the order in which the children are named in the will is correct. This assumption is born out in part by the dates of marriage of the various children. The signature of Richard Haines is shown below:

She was chosen an overseer of Goshen MM on 10 mo. (Dec.) 3, 1725, and served in this capacity until her death. His family may not be complete. Inasmuch as he only mentioned his two sons in his will, it is possible that there were other children who died before their father, without children. Nothing certain is known about the family of Joseph Haines and Hope Reeves, but most likely they had a daughter born June 30, 1758; another daughter born December 13, 1760; and a son born May 2, 1765. It seems likely, too, that they had a son Henry, possibly older than the son born in 1765. No other Henry Haines appears in the records who could have had a son born in 1788, and it seems likely that Hope Haines might have named a son after her father. Besides, there were close connections between the Haines and Reeves families. Theodocia Powell, who marrired Henry Haines, had a sister Elizabeth who married Henry Reeves, and another sister, Martha, who married William Reeves. In one deed in Mt. Holly, N.J., Henry Haines was actually referred to as Henry Reeves in one instance. No doubt there were other children than the ones given below, but their names have not been learned. It seems likely that Joseph Haines, who died at Vincentown on Dec. 18, 1859, aged 89 years, and whose parents were Joseph and Mary Haines, was the son of Joseph and Mary (Reeves) Haines. His age might not have been correct, to the exact year. He was listed in the 1830 census as being in the 50-60 age group. Joseph Haines died intestate. Letters of Administration were granted Jan. 27, 1785, to Mary Haines, of Mansfield Twp., and to Joseph Pancoast. An inventory of his personal property was taken Feb. 16, 1785, by Henry Reeves and John Aaronson.
