THE LUKENS FAMILY

JAN LUCKEN, a weaver by trade, emigrated from Crefeld July 24, 1683, in the ship "Concord," with the group of pioneers who were the founders of Germantown, and arrived at Chester October 6, 1683.

His wife's Christian name was Mary, her surname is not known. The late Dr. Learned of the University of Pennsylvania and the late Gov. Samuel W. Pennypacker both were of the opinion that showas Mary Tyson, sister of Reynier Tyson, which is highly probable.

Jan Lucken brought with him an old Bible published in 1595 V by Peter Sebastian in which he recorded the births of his children, of which the following is a copy:

This interesting old Bible was in possession of William H. Lukens of Gwynedd in 1897, and the records therein were published in the Spencer Genealogy.

THE JAN"LUCKENS HOUSE

This quaint old house was built in 1708. It is situated north of Tabor station, just off of Olney Avenue and Nedro-Avenue, between Grange and Chew streets, Philadelphia. It is known as the "Grange Farm," and was occupied by the Highland troops when the British held Philadelphia in 1777. – grain and forage being stored in the barn.

The following deed is recorded in the "Grund und Lager Buch ":

Indenture 3. 8. 1697, between John Luken of Germantown, husbandman, and Mary his wife, to Eve Bellinge for 50 acres. Twenty acres thereof in the inhabited part of Germantown and 29 acres in the sideland thereof granted by Benjamin Fyrley, Agent and Attorney of the Frankfort Company at Rotterdam, to John Luken, by virtue of a deed of 200 acres unto him the said John Luken, which deed beareth date the 8th of June 1683. Confirmed by Francis Daniel Pastorius, Attorney of the s'd. Frankfort Company. The said fifty acres laying in Germantown, bounded on the South East with the lot of Reiner Tisen and on the North West with the lott and land of Abraham Tunes.

Thomas Kunders, Recorder. Peter Schumacher, Justice. Passed in the Court of Record, the 7th day of the 7th mo. 1697.

The "German Lager Buch" of Germantown is mostly in the handwriting of Francis Daniel Pastorius. The book is written largely in German, other portions in English and Latin. For over two centuries the book was in the custody of the Recorder of Deeds of Philadelphia, but through the instrumentality of the late Gov. Samuel W. Pennypacker, the original book was presented to the Historical Society of Pennsylvania, and a translation of the text made by Dr. Marion Dexter Learned of the University of Pennsylvania, and the copy given to the Recorder, which can be examined by those interested upon application.

Jan Lucken owned extensive tracts of land in Germantown and vicinity. One of these tracts was situated in Towamencin Township, and extended from the brick church to Kulpsville. Another tract of 500 acres was located on what is now the Doylestown and Willow Grove turnpike, on the county line, a part of which was known as the Jarrett farm, and afterwards the Hallowell farm.

The will of Jan Lucken of Germantown, weaver, dated 8th month 9th, 1741, and proved January 24th, 1744, names sons Mathias and Abraham as executors, and provides in the event of the death of either, his son Joseph shall act instead. To son Abraham, Three hundred acres of land whereon the said Abraham now dwells, being part of 500 acres bought of Benjamin Furley's attorneys and situate in Towamensing township above North Wales (now Montgomery county), adjoining land of William Tunnis, formerly belonging to George Claypole and Jacob Gotschalk, to be laid out so as to include the spring called "The Pan."

All the rest of his property to be kept whole during the lifetime of his wife Mary, and she to have the house and lot in Germantown "where I now live."

To granddaughter Sarah Conrads £6.

At the death of his wife Mary, the remainder of the five hundred acres in Towamensing, viz. two hundred acres and the house and lot, to be sold by his executors and the proceeds therefrom to be divided into eight portions to his grandchildren, one to the children of son William, deceased, one to the children of son Peter, deceased, one to the children of son Mathias, one to the children of son Abraham, one to the children of son Joseph, one to the children of daughter Mary, one to the children of daughter Hannah and one to the children of daughter Alitze Conard.

DESCENDANTS OF JAN AND MARY (TYSON?) LUCKEN Jan and Mary Lucken had issue 11 children: Elizabeth, Elsie or Alice, William, Sarah, John, Mary, Peter, Hannah, Mathias, Abraham and Joseph.

William, b. 12. 22. 1687/8, d. 2. —. 1739/40, m. 9. 27. 1710, at Abington Meeting, Elizabeth Tyson, b. 1690, d. 2. 18. 1765, daughter of Rynier and Margaret Tyson.*

* Theodore Roosevelt, President of the United States, is a descendant of this marriage, as follows: Elizabeth Lukens m. Thomas Potts.

Sarah, b. 7. 19. 1689. No further record, probably died young. John, b. 9. 27. 1691, d. 4. —. 1737, m. 12. 25. 1711, at Abington Meeting, Margaret Cursterd (Koster, Custer, etc.).

Mary, b. 11.'18. 1693, m. 10. 29. 1712, at Abington Meeting, John Gerrit. Most of their descendants are now called Jarrett.

Mathias, b. 8. 13: 1700, d. 2. —. 1741/2, m. 2. 24. 1721, at Abington Mtg., Ann Johnson, daughter of Dirk (Richard) and Margaret (Millan) Johnson. He d. 1791. Issue: Dirk, John, Daniel, Mary, Hannah, Anne, Rebecca and Sarah.

Dirk (Richard) Lukens, son of Mathias and Ann (Johnson) Lukens, d. 7. 11. 1777, m. 1. 27. 1753, at Christ Church, Philadelphia, Elizabeth Graeme, a niece of Dr. Thomas Graeme, d. 9. 6. 1786 (Bible record), buried at Germantown 9. 7. (Abington Mtg. record).

The will of Derick Lukens, dated July 8, 1777, pr. Feb. 6, 1779, at Philadelphia (Will book R, p. 160), mentions wife Elizabeth; children James, Mathias, Derick, Daniel, Anna, Mary, Hannah, Margaret, Sarah and Rebecca. Executors: brother

Elizabeth Potts m. Sept. 22, 1778, Robert Barnhill.

Margaret Barnhill m. Cornelius Van Schaack Roosevelt.

Theodore Roosevelt m. Dec. 22, 1853, Martha Bullock. Theodore Roosevelt, President of the United States, was their son. (Roosevelt Genealogy, p. 50.)

Daniel and sons Daniel, James and Mathias. Witnesses: Charles Bensel and Augustine Neisser. His Bible is in possession of Miss Williams, 1716 N. 55th St., W. Philadelphia, 1922.

DESCENDANTS OF WILLIAM AND ELIZABETH (TYSON) LUKENS

William Lukens, b. 1687, son of Jan Lucken, the immigrant, and his wife Mary Tyson, m. 1710, Elizabeth Tyson, daughter of Reynier and Margaret Tyson. (Theodore Roosevelt, President of the United States, was a descendant of this marriage.)

William Lukens, d. 1803, son of William and Elizabeth (Tyson) Lukens, m. (2d) Elizabeth Pennington.

Benjamin Lukens, b. 1769, d. 1846, son of William and Elizabeth (Pennington) Lukens, m. 1798, Martha Daves, b. 1777, d. 1830, daughter of Isaac and Susanna Daves.* (Their granddaughter Martha, born in the Lukens home at Horsham, Pa., was the beloved stepmother of James Whitcomb Riley, the poet, of Indiana.)

Elizabeth Lukens, b. 1811, d. 1896, daughter of Benjamin and Martha (Daves) Lukens, m. 1830, Oliver Walton, b. 1807, d. 1869, son of Jeremiah and Hannah (Malone) Walton, and a descendant of John Kirk.

John Walton, b. 1842, d. 1916, son of Oliver and Elizabeth (Lukens) Walton, m. 1877, Alice Conard, b. 1843, daughter of Joseph and Rebecca (Shaw) Conard, and a descendant of Thones Kunders, the Germantown pioneer.

Susanna Lukens Walton, daughter of John and Alice (Conard) Walton, was born Jan. 8th, 1878.

Adjacent to the old Horsham meeting-house, in Montgomery

County, Pa., and probably contemporary with it, is an old homestead in which have dwelt three generations of the Lukens family (see picture). The house nestles in the low hills, and is surrounded by a meadow through which flows the Pemmapeck (Pennypack) Creek. Here lived William Lukens, grandson of Jan Lucken the immigrant, followed by his son Benjamin and his wife-Martha Daves, and later by their son Isaac and his wife Martha.

In 1836, when his son Isaac was married, Benjamin Lukens built in Horsham a new house, now the home of his greatgranddaughter, Susanna Lukens Walton. She was born in 1878, and educated at Horsham Friends' School and Peirce Business College, Philadelphia. She was associated with her father, John Walton, in the real estate business, and after his death in 1916 she continued to carry on the business. In 1922 she was elected a director of the Willow Grove Trust Company,—the first woman bank director in eastern Pennsylvania,—and ever since the opening of the Trust Company she has had charge of its title department.

Both John Walton and his daughter Susanna have always been public-spirited citizens, interested in the Horsham Friends' School, the Horsham Fire Company, and all other institutions and movements that tend to advance the welfare of the community.

Their daughter, Edith Iredell, b. 1790, m. 1813; David Wilson. Their daughter, Rebecca A. Wilson, b. 1832, m. 1853, Henry C. Young. Their daughter, Elizabeth Marion Young, b. 1861, m. 1896, George B. Miller, son of J. Washington and Mary (Bremer) Miller. They reside (1924) at The Newport, Philadelphia.

THE TYSON FAMILY

Reynier Tyson, b. about 1659, d. 7. 27. 1745, aged about 86 yrs., m. Margaret Streypers.

As is mentioned in the Streypers Family sketch, Reynier Tyson was one of the thirteen original settlers of Germantown. He is named in William Penn's charter, Aug. 12, 1689, as one of the original incorporators of the borough of Germantown. He served as Burgess or Mayor of Germantown 1692-1693-1694-1696.

A biographical account in "The Friend," Vol. XXX, p. 229, states: "He was innocent and inoffensive in life and conversation, and diligent in attending his religious meetings."

On 5. 25. 1725, he was chosen as Elder of Abington Friends' meeting.

He represented Jan Streypers' children living in Holland in a dispute with Jan Streypers, son of William. (Streeper Papers, MS., Historical Society of Pennsylvania.)

The will of Reynier Tyson of Abington, dated 10. 21. 1741, pr. Oct. 26, 1745 (Phila. Wills H, p. 63), mentions grandson Matthew Tyson son of Matthias; sons John, Abraham, Derrick, Peter and Henry; daughters Elizabeth Lucken and Sarah Kirk. To his daughter Elizabeth Lucken he left "all my Dutch books." Granddaughter Abigail Tyson "my riding-horse." Executor: son Isaac.
